


Rear Upper Trailing Arms Kit Installation Instructions SPL RUT NC





Thank you for your purchase of this SPL Parts performance suspension product. Please follow these instructions exactly to ensure that the product is able to function to the best of its ability, and you can achieve the most performance out of your vehicle.

- 1. Chock the front wheels of your vehicle and loosen the lug nuts on the rear wheels.
- 2. Jack up the rear of the vehicle by the factory recommended jacking points, then place the car on jack stands. Remove the rear wheels and place them to the side.
- 3. Remove the bolt that holds the stock rear upper traction arm to the knuckle, then remove the bolt that holds the arm to the subframe.
- 4. Adjust the SPL Parts arm to be the same length as the OEM arm while they are both off the car. Make sure to adjust both FK Rod Ends (3, 4) at the same time. This can be done easily by holding the FK Rod Ends in place and instead turning the Aluminum Turnbuckle (1) to change length.

MAX 5/8 In.

Even though the SPL RUT NC does not include a double adjuster, it is important to note the maximum articulation of the FK Rod End. The **max** is **5/8 in.** as shown to the right.

- 5. Place the Tapered Spacer (7) inside the knuckle.
- 6. Place the FK Rod End (4) on top of the tapered spacer, then slide the Bolt (10) through the assembly.
- 7. On the bottom of the assembly, place the Washer (8), followed by the Locknut (9). Tighten the knuckle end down to 50 **ft.-lbs**.
- 8. Slide the opposite end into the subframe, making sure that the FK Rod End is in the middle of its articulation. Place the OEM bolt through and



tighten to 60 ft.-lbs.

- 9. Tighten the Blue Titanium Socket Head Cap Screws (6) down to 12.5 **ft.-lbs.** (150 **in.-lbs**.). Make sure the allen key is fully seated before tightening. **DO NOT OVERTORQUE.** SPL Parts is not liable for any issues due to overtorque.
- 10. Take the car to an alignment shop. We suggest bringing these instructions with you to give to the tech working on your vehicle.
- 11. Be safe, and enjoy your new upgrade!



Make sure to keep the rod end bearing centered during and after an alignment. The far-right image with the green check mark is the correct position.
